Everyone who accesses this website assumes the role of user, committing themselves to the strict observance and compliance with the provisions indicated here, as well as any other legal provisions that may apply at any time.

For the purposes of the provisions of the General Data Protection Regulation (RGPD 2016/679) and Law 3/2018, of 5 December, on data protection and guarantee of digital rights, the personal data provided to us through the forms of the web, customer account registration and orders, online store purchases, etc. will receive the treatment of "user" data.

## **Purposes of data processing**

We process the personal data of our contacts, partners, users and customers in order to manage the relationship with our entity and, in particular, the contractual aspects, the sending of information of our entity and the sector, and the sending of informative and commercial communications (also by electronic means) and the sale of the products that appear in the catalog of the online store.

All the data you provide us through the registration and creation of a user account, the order order and / or the contact forms, will be incorporated into a database owned by AGRICOLA I SC CABACES for the purpose to be able to manage the application or orders and their billing, and also to send information on products and services marketed by AGRICOLA I SC CABACES, as well as for the sending of commercial promotions of other companies related to the sectors that may be of interest to you.

## **Data retention**

Customers' personal data will be kept for a period of 5 years in accordance with current tax regulations.

Contact details will be retained until deletion is requested.

In any case, AGRICOLA I SC CABACES will retain your personal data for as long as they are necessary for the provision of contracted services, unless we are asked to delete them. However, they will be kept for the period of time necessary to comply with the legal obligations that correspond in each case in accordance with the type of data and the purpose of obtaining them.

## **Legitimation for data processing**

The legal basis for the processing of your data is in most cases the existence of a previous contract with AGRICOLA I SC CABACES, or in its absence, the express consent of the user, granted in the forms provided you can fill in and in the orders placed in the online store.

The prospective or commercial offer of products and services is based on the consent requested. In any case the withdrawal of this consent will condition the process of the sale.

Unless specifically stated otherwise, it will be considered necessary to complete all the required data in the forms and sections that you will find on this website.

## **Recipients**

The data may only be communicated to organizations linked to AGRÍCOLA I SC CABACES in the field of the management of their products and / or services for the same purposes referred to above, as would be the case of transport companies, as well as those competent Public Administrations when required by current regulations.

The staff of AGRÍCOLA I SC CABACES may access your data according to each of the purposes of the treatment and with the objectives described in this Privacy Policy. All AGRÍCOLA I SC CABACES employees have been trained and informed of their responsibilities in this regard and sign the corresponding confidentiality agreement and good practice. Also those organizations necessary for the proper management of the provision of the service can access your data, such as computer providers and website managers, postal and courier companies or payment management companies.

AGRÍCOLA I SC CABACES has established contracts or contractual agreements and security measures with these third parties, to ensure the appropriate level of security and protection of personal data.

## **Rights of the interested party**

You may request access, rectification, deletion, limitation of processing, portability and opposition to the processing of your data at any time.

## **Data type**

The basic identification data (name, surname, NIF), contact details (postal and e-mail address, telephone number) and bank details (credit card number) are preprocessed. Specially protected data categories are not processed.

No information is deleted unless the user requests the deletion and, as long as the deletion is appropriate. The information is always available, although it may be blocked for deliveries of an informational, marketing and / or commercial nature, if the rights of suppression, limitation of treatment or opposition by the user have been exercised.

### **Security incident response policy**

AGRÍCOLA I SC CABACES has adopted appropriate technical and organizational protection measures and these measures apply to data that could be affected by potential security breaches. There is no access to customer / user data by people who are not authorized to access it. In the event that AGRÍCOLA I SC CABACES identifies a breach of security of personal data that compromises its users, the competent authority will be notified within the next 72 hours and the users, if any, as soon as possible.
